1. CALL TO ORDER

Chair Kristin Derrig called to order the meeting of Wednesday, May 16, 2018 at 12:36pm. Secretary Tory Canfield took roll and determined that a quorum was present.

3. PUBLIC COMMENT PERIOD FOR ITEMS NOT ON THE AGENDA (including questions from Press) Tom Blanchard said there was an article in the *New York Times* regarding walking communities in European cities and thought the other board members would be interested.

4. PRESENTATION: III-A Annual Report by Amy Manning, Executive Director, III-A

Amy Manning, Executive Director of III-A, gave a presentation regarding III-A insurance annual report. III-A is a self-funded health insurance trust that Mountain Rides joined last year. III-A was founded 6 years ago by Idaho cities in response to rising health care costs. All Idaho public agencies who are eligible are welcome to apply. They are successful in their mission to help public agencies with their benefits. The trustees agreed to add hearing aid and 3-D Mammogram imaging benefits this year.

5. PRESENTATION by Wally Morgus about the Ketchum Circulator

Wally Morgus said the City of Ketchum approved supporting and funding the new Ketchum Circulator route for seven days a week from 5:30-10:30pm.

Ben Varner said the grant is for \$60K but the costs are all over the place with different companies.

Tom Blanchard asked the traditional use of the contingency fund.

Tucker Van Law said we used it to build the South Valley facility. We would like to increase the contingency fund to 15-18% of operating coast and right now it is about 10%.
