Staff conferred with Workman & Co. CPAs regarding removal of the Business Manger as a signatory; Workman continues to recommend that the Business Manager (Director of Finance & Administration) not be a signatory. Current Resolution reflect this. F&P Committee vetted the revised Resolution at its Dec 5, 2018, meeting and recommends approval and adoption of the resolution by the Board of Directors.
