# REGULAR MEETING MINUTES MOUNTAIN RIDES TRANSPORTATION AUTHORITY Wednesday, February 20, 2019, 12:30 p.m. Ketchum City Hall Meeting Room, Ketchum, Idaho

#### 1. CALL TO ORDER

Chair Kristin Derrig called to order the meeting of Wednesday, February 20, 2019 at 12:30pm. Tory Canfield called roll and determined that a quorum was present.

## 2. COMMENTS FROM THE CHAIR AND BOARD MEMBER THOUGHTS

Grant Gager thanked the staff for all their hard work over the holiday weekend. Kristin Derrig and Kathleen Kristenson said they were impressed with how Mountain Rides handles the buses with all the snow we have had.

- Rick Webking asked about the performance dashboard, item 4b, ridership on the Hailey route and vanpool. He also asked about an accident noted. Ben Varner said it was not our fault, someone hit our bus with their door and the other party will pay for the cost of that.

Tom Blanchard asked about the revenues and expenses for the month.

Grant Gager asked about item 4gii, regarding the historic records and if this is guided by state statute. Tucker Van Law responded that when we save in dropbox, documents and items are saved in the cloud and on our computers.

Grant Gager moved to approve the Consent Agenda. Tom Blanchard seconded. The motion passed.

# 5. DISCUSSION ITEM: Battery – Electric bus demo day, Mon, Feb 25, 2019

Kim MacPherson described the schedule for the day. The electric bus will be parked at Ketchum City Hall and Proterra CEO, Ryan Popple, will go into the council chambers to speak about electric buses.

Ben Varner said that Proterra is the only bus company designing electric buses only. Even though this visiting bus is 40 ft, we will be getting 35 ft buses for our fleet.

### 6. DISCUSSION ITEM: Preliminary Summer 2019 Service Plan Considerations

Ben Varner said we want to get some board input and ideas of service improvements. Tory Canfield asked about taking the Ketchum Circulator to the City of Ketchum for winter service and not having it just in the summer.

From an operational point of view, Ben Varner said that we should look at the Red Route decoupling West Ketchum and Elkhorn.

Grant Gager suggested a need for service to River Run in the summer and staff reaching out to Sun Valley Company.

Rick Webking asked about Red Route service in the summer. Kim MacPherson said we will keep Red Route service to the symphony in the summer.

Tom Blanchard asked about Valley Route evening service. Ben Varner said Sunday service is the one day that is lacking service and staff would like to expand weekend service at some point.

Grant Gager suggested asking the BCRD if they would like to fund service to Galena lodge in the summer.

Rick Webking mentioned that in the Finance & Performance committee meeting, the group spoke about finding a consultant to research electric buses.

#### 7. ADJOURNMENT

Tom Blanchard moved to adjourn the meeting at 1:29pm. Rick Webking seconded. The motion carried unanimously.
